All [required PRC documents](#) must be complete and uploaded into the IRBIS system, with ALL departmental signoffs completed by the PRC deadline indicated. Submissions with incomplete documents or without relevant signoffs will NOT be considered as submitted by the indicated deadline. Studies submitted by the relevant deadlines will be scheduled for **both** a PRC Meeting and a related IRB Meeting to take place five days subsequent to the PRC Meeting. There may be circumstances when this is not possible, in which case it will assigned to the next available meeting(s).**
